## **DIRECTIONS**

**NOTE:** Prior to use, always check an obscure area of surface to determine color fastness of fabric. Do not use on wool or velvet fibers. **Pre-Spray:** On stained or heavily soiled areas, pre-spot with a solution of product at a rate of 1 to 10 (13 oz/1 gal) of water. **Extraction Method-Normal Soil:** Pre-dilute concentrate with water at a rate of 1 to 128 (1 oz / 1 gal) of water. **Extraction Method-Heavy Soil:** Pre-dilute concentrate with water at a rate of 1 to 64 (2 oz / 1 gal) and add to solution tank of unit. Using hot water will provide greater performance in most solutions. **Spray On Method:** Pre-dilute concentrate with water at a rate of 1 to 16 (8 oz/1 gal). Use a pump-up type sprayer and mist the entire carpet with this solution. After area has been covered with product, extract with clear water using steam, hot or cold water. **Truck Mounted Systems:** Set dilution control systems to yield 1 to 10 ratio with water (13 oz/1 gal).


